K Vick – Questioned why the council approved the entryway to the park because it doesn't appear to follow the park master plan. The new sign doesn't say park and will be located on Hegel Road. She feels like it should have been a decision for the Planning Commission and the Parks and Recs.

D Fredricks – Stated that council should be there for residents, not the employees. They need to not give raises, have no DPW and stop spending their money.

H Wartella – Should not have a full time DPW because he thinks there is too much down time. Doesn't think they do anything and they are terrible.

P Wartella – Feels like the council has made no attempt to save money. Council seems to cater to the administration by spending money on employees with health care, cost of living raises and having a DPW. They should be spending money on infrastructure and contract everything out.

C Bebee – Stated that Vick found money in the budget and it should go to the dam. Council should show people they care and shouldn't have hired the DPW worker let alone give him ten more hours a week. Why was Sidge and Horton allowed to do whatever they want with healthcare?
