3. Aquatic Nuisance Plant Control Contract  
**MOTION:** To accept the proposal to treat the Mill Pond up to two times in the 2006 season for higher aquatics and algae, the first treatment to be done, sometime in June, depending on plant growth @ a cost of \$3,675. If the second treatment is needed the cost will be \$2,950.

5. Sewer charge dispute 10240/42 Hegel Road – Bill Rausch presented a claim to council that the building he purchased from the village several years ago should have been hooked up to sewers and the village taxpayers owe him \$8000 in expenses. The council questioned if the building was purchased “as is” as the building was being considered for demolition and it would not have been financially prudent to use taxpayer dollars to hook sewers to it. Audience member Jay Clothier addressed the council regarding the statute of limitations. President York stated the council would take it under consideration as they did not have enough facts to make a decision at this time.
